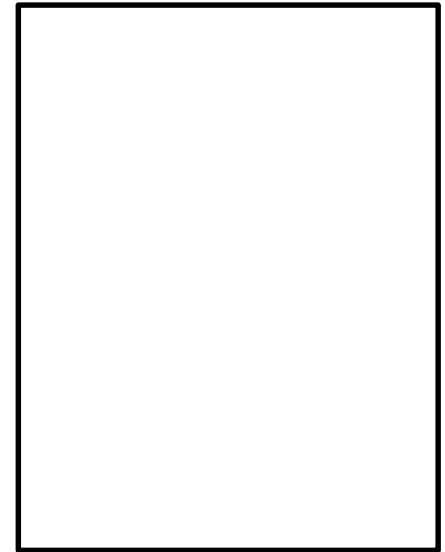

In the condition of participation of my child in The Salvation Army's youth ministry programs at the Ray and Joan Kroc Corps Community Center, I agree, on behalf of myself and my child, to make no claims or file any lawsuits against The Salvation Army or any of its agents or employees or volunteers for any loss or damage to my child's personal property or for any injury to my child. To the maximum extent permitted by law, this liability waiver will apply regardless of whether the injury or damage was caused by the negligent act or omission of The Salvation Army or anyone acting on its behalf. I further agree to defend, indemnify and hold harmless The Salvation Army, its agents, employees, and volunteers against liability for any claims, lawsuit, losses, damages, or expenses arising out of any personal injury or property damage caused by my child in connection with his/her participation in the program.

I understand that during the youth ministry programs my child may take part in activities which may require travel in a Salvation Army vehicle. It is my understanding that participating in the programs and recreational or other activities of The Salvation Army is a privilege. Prior to participation in such activities, I acknowledge that there are certain risks associated with the activities, including, by way of example, physical injury due to activity-related accidents, physical injury due to transportation-related accidents, illness, including risks associated with the novel Covid-19 Virus, or even death. In addition, I acknowledge that there may be other risks inherent in these activities of which I may not be presently aware.

I do hereby authorize The Salvation Army Ray and Joan Kroc Corps Community Center as agent for the undersigned, to consent with respect to said minor, to any x-ray, examination, anesthetic, medical, dental, or surgical diagnosis or treatment, and hospital care which is deemed advisable by, and is to be rendered under general Illinois Medical Practice Act by the medical staff of any hospital, whether such diagnosis or treatment is rendered at the office of the physician or at the hospital. I understand that The Salvation Army Ray and Joan Kroc Corps Community Center is not responsible for the cost incurred for medical care.
